

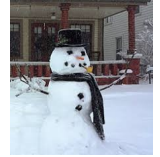

2019 TAXES

Taxes for 2019 may be paid at the Fredonia Village Hall, 242 Fredonia Avenue, Fredonia, Wisconsin, during normal business hours. The Village Hall is open Monday through Friday from 8:30 A.M. until Noon and from 1:00 P.M. until 4:30 P.M. Checks for payment of taxes should be in the correct amount. **If an overpayment occurs, the refund will be made by check within fifteen business days to the property owner.**

The Village Hall will be **closed** :

All day Wednesday, December 25, 2019
At noon on Tuesday, December 31, 2019
All day Wednesday, January 1, 2020

IF A RECEIPT IS DESIRED, A SELF-ADDRESSED, STAMPED ENVELOPE MUST ACCOMPANY YOUR PAYMENT. **You may pay your taxes online using your credit or debit card. Please see the link on the Village website. A service fee will apply. Credit and debit card payments are also accepted at Village Hall. Or, feel free to use our convenient drop box for after hours service. It is located to the right of the entrance doors at Village Hall.**

Real estate taxes may also be paid at Port Washington State Bank in Fredonia. Taxes will be accepted inside the bank lobby only which is open Monday through Thursday from 9:00 a.m. until 5:00 p.m.; on Friday from 9:00 a.m. until 6:00 p.m. and on Saturday from 9:00 a.m. until noon. Please bring your tax bill with you. Any tax refund will be issued immediately by the bank.

DOG LICENSES

When mailing in your taxes, please be sure to include a **separate** payment for dog licenses. The cost is \$10.00. If the animal is neutered or spayed, the cost is \$5.00. Information required includes dog's name, color, breed, sex, and evidence of rabies vaccination, including date. (License can not be issued without proof of vaccination). **Dog licenses may only be obtained at the Fredonia Village Hall.** All dogs in the village must be licensed that are 5 months of age and older. Licenses issued after March 31 will have a \$5.00 late fee assessed.

This is to give you notice that the Fredonia Municipal Water Utility filed an application that was approved by the Public Service Commission of Wisconsin (PSC), for authority to increase water rates. Rates for general service will increase 3.0 percent. The increase is necessary to reduce the existing deficiency in present rates. The request is being made under Wis. Stat. 196.193. Rate increases granted under this statute do not require a public hearing. The effect of the increase for some selected customers is shown above. Public Fire Protection and Wholesale rates (if applicable) will also increase 3.0 percent.

This rate increase will go into effect on December 30, 2019. If you have any questions about the rate increase, call the Fredonia Municipal Water Utility at (262) 692-9125.
