2020 TAXES

Taxes for 2020 may be paid at the Fredonia Village Hall, 242 Fredonia Avenue, Fredonia, Wisconsin, during normal business hours. The Village Hall is open Monday through Friday from 8:30 A.M. until Noon and from 1:00 P.M. until 4:30 P.M. Checks for payment of taxes should be in the correct amount. **If an overpayment occurs, the refund will be made by check within fifteen business days to the property owner.**

If you do not wish to come inside the Fredonia Government Center due to COVID-19 concerns, you are welcome to place your payment in our drop box located outside the entrance doors on the right (east) side. We will mail you a receipt if you request one.

IF A RECEIPT IS DESIRED, A SELF-ADDRESSED, STAMPED ENVELOPE MUST ACCOMPANY YOUR PAYMENT. **You may pay your taxes online using your credit or debit card. Please see the link on the Village website. A service fee will apply. Credit and debit card payments are also accepted at Village Hall. Or, feel free to use our convenient drop box for after hours service. It is located to the right of the entrance doors at Village Hall.**

Real estate taxes may also be paid at Port Washington State Bank in Fredonia. Taxes will be accepted either inside the bank lobby or the drive thru! Please bring your tax bill with you. Any tax refund will be issued immediately by the bank. The bank lobby which is open Monday through Thursday from 9:00 a.m. until 5:00 p.m.; on Friday from 9:00 a.m. until 6:00 p.m. and on Saturday from 9:00 a.m. until noon. The drive thru is open Monday through Friday from 8:30 a.m. - 6:00 p.m. and 9:00 a.m. - noon on Saturday.

CHRISTMAS TREE DISPOSAL

The village crew will pick up discarded Christmas trees each Monday in January. Please place your tree curbside before 7:00 a.m. Wreaths are disposed of by placing in your regular trash cart.

DOG LICENSES

When mailing in your taxes, please be sure to include a **separate** payment for dog licenses. The cost is \$10.00. If the animal is neutered or spayed, the cost is \$5.00. Information required includes dog's name, color, breed, sex, and evidence of rabies vaccination, including date. (License can not be issued without proof of vaccination). **Dog licenses may only be obtained at the Fredonia Village Hall.** All dogs in the village must be licensed that are 5 months of age and older. Licenses issued after March 31 will have a \$5.00 late fee assessed. Failure to license your dog(s) may result in a fine of over \$200 if your dog is at-large or any other issue where police are involved.



TRASH AND RECYCLING HOLIDAY EDITION

Trash and recycling pick up for Christmas holiday will be Saturday, December 26, 2020 and for New Year's on Saturday, January 2, 2021. All items must fit in the cart with the lid closed. **Please note: gift wrapping paper is considered trash.**
