## GENERAL RULES AND REGULATIONS

- 1). A lease for use of Stoney Creek Park will be taken out.
- 2). For village residents, a fee of **\$80.00** will be payable in advance to the Village Clerk/Treasurer. For non-village residents, a fee of **\$90.00** will be payable in advance to the Village Clerk/Treasurer. If park and restrooms are left in good condition **\$50.00** of this fee shall be refunded. If, however, damage is done or facilities have not been cleaned, the entire deposit shall be retained in addition to all costs of repair or cleaning.
  - a. **Restrooms must be cleaned and returned to "like new" condition.**
  - b. **Picnic tables must be cleaned.**
  - c. **Floor must be swept. If needed, floor must also be mopped.**
  - d. **Garbage must be put in the dumpster outside.**
  - e. **Keys must be returned to the Village Hall within 24 hours.**
- 3). Applications shall be filed with the Village Clerk/Treasurer at least fourteen days prior to the date on which the exclusive use of the entire park is requested, or at least three days prior to the date on which a park shelter or portion of a park is to be used.
- 4). **Keys for the bathrooms and dumpster must be picked up prior to the date on which the park is reserved. The keys can be obtained at the Village Hall weekdays between the hours of 8:30 a.m. and 4:30 p.m.**
- 5). **Volleyball nets, balls, and horseshoes are included with the rental fee. These must also be picked up at the Village Hall prior to the date of park use.**
- 6). A fire extinguisher will be on site and readily attainable at all times.
- 7). Loudspeakers shall be directed toward the municipal building.
- 8). Debris shall be cleaned up the night of use. Tents, etc. shall be down within four days of the event.
- 9). All groups or parties sponsored or attended by minors must be chaperoned by adults 30 years old or older who must be in the park during the entire period of assembly.
- 10). Intoxicating beverages cannot be sold nor served to any minor under the legal drinking age.
- 11). If applicable, the area including the beer tent and the band shell shall be roped off to prevent minors from entering.
- 12). The person who signed the application for any reservation becomes responsible for the conduct of the group and for any and all damages that may result by virtue of the assembly.
- 13). No disorderly conduct shall be allowed.
- 14). These grounds cannot be reserved, nor used unreserved, for political purposes, except by special permission, application for which can be made at the Village Hall.
- 15). No person shall sell, keep or offer for sale, any tangible article, merchandise, or thing, nor solicit for any trade, occupation, business or profession, within the park without the written permission of the Village Board.
- 16). No person shall distribute, post, affix, or display any card, hand bill, sign, placard, target, banner, flag, (except that of the United States), or advertisement or any kind within the park or upon any of the enclosures thereof without the written permission of the Village Board.
- 17). No littering.
- 18). No firearms or dangerous weapons shall be allowed.
- 19). No dogs permitted.
- 20). Destruction or defacing of property forbidden.
- 21). No dangerous drugs shall be allowed.
- 22). No gambling.
- 23). No cars or bicycles or other recreational vehicles shall be allowed except in the parking lot.
